EMERGENCY AID FOR NATURAL DISASTERS

The climate change-intensified natural disasters of 2017 have laid bare the federal government's current response as both politicized and racist. How would you identify and legislatively fix underlying structural flaws in federal disaster relief and preparedness funding to ensure more timely, equitable, a effective federal responses to future events? (No more than 250 words)

A major reason for our complex and inefficient system is that funding for disaster response and recovery is "off-budget," meaning the funds are not counted against discretionary spending limits and therefore not required to be offset by spending reductions in other programs. Congress must reevaluate the Stafford Act, the 1988 law which guides federal emergency response. The statute, in many cases, imposes limitations on rebuilding infrastructure, often resulting in assets being rebuilt as they were before the disaster without factoring in threats such as those from climate change. In 2016, the Joint Committee on Taxation estimated that there is now \$2.6 trillion in "earnings of foreign subsidiaries of U.S. corporations held offshore," up from \$2.3 trillion in 2012. Closing tax loopholes and repatriating these funds from Bermuda, the Cayman Islands and other tax shelters would go a long way to addressing future disaster relief funding challenges.
